## **NOTICE INVITING QUOTATION**

Sealed quotations are invited from intending and experienced bonafide Agencies for the supply of one Commercial RO System at Administrative Training Institute (ATI), Govt. of West Bengal, Sector-III, FC Block, Salt Lake, Kolkata-700106.

# The specifications of the Commercial RO System are given below:-

### **SPECIFICATIONS**

#### Commercial RO System:

- 1. Purification by Reverse Osmosis (RO) + Ultra Filtration (UF) + Ultra Violet (UV) + Total Dissolved Solids (TDS) control.
- 2. Purification capacity of 50 ltrs / hr.
- 3. Should have 4 numbers RO membranes and 2 high pressure pumps allowing high flow-rate of upto 50 litres/hour of purified water, making it possible to install with water coolers.
- 4. The user should be able to adjust the TDS level of purified water from raw water having TDS level greater than 500 ppm.
- 5. The provision for the installation of an optional hydrostatic storage tank of 8 or 20 litres capacity which can be attached to the RO System. The hydrostatic tank should ensure pressurized supply of purified water even in the absence of electricity or running tap water.
- 6. Fully automatic operation allowing the RO System to begin purification whenever water level in the purified water storage tank falls below maximum, and stop when the tank is filled or when there is no inlet water supply and thereby ensuring trouble free operation without the need of manual intervention.
- 7. RO membrane housing should be spin-welded thereby ensuring high quality permanent joints to prevent tampering and improving membrane life.
- 8. All the fittings and components in the RO System should be push (snap) fit to prevent leakages and wastage of water. Additional protection against leakages should be built-in by using rubber O-Rings inside the push-fit fittings.
- 9. Should have a built-in rugged SMPS (Switching Mode power supply) instead of a standard power adaptor equipped to handle a wide range of input AC voltage (100 300 Volts) enabling the RO System to stay resilient towards frequent power fluctuations.
